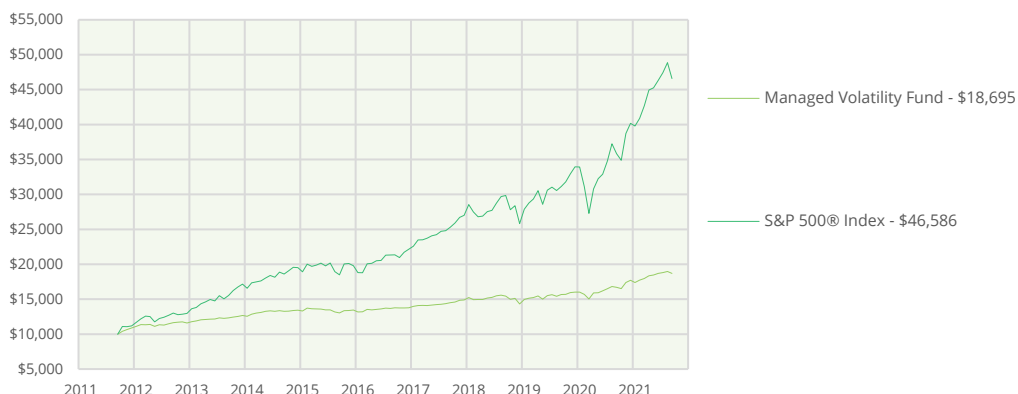

A beta above one is more volatile than the overall market, while a beta below one is less volatile.*
