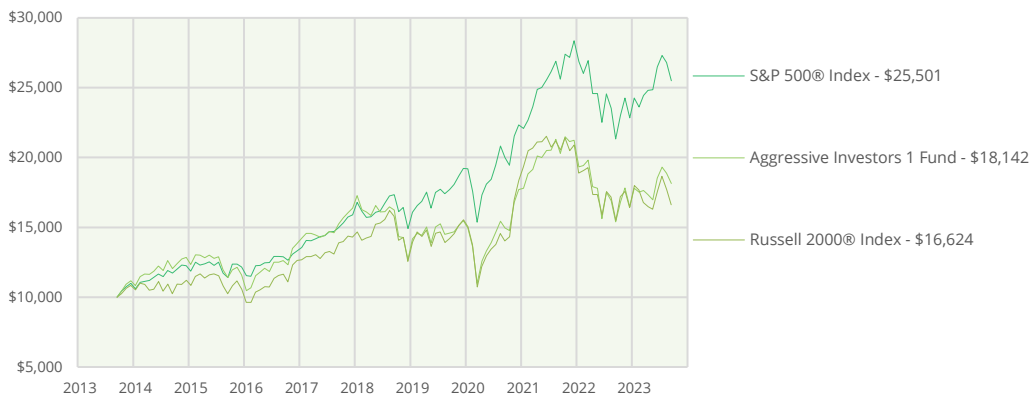

Investments in the small companies within this multi-cap fund generally carry greater risk than is customarily associated with larger companies. This additional risk is attributable to a number of factors, including the relatively limited financial resources that are typically available to small companies, and the fact that small companies often have comparatively limited product lines. In addition, the stock of small companies tends to be more volatile than the stock of large companies, particularly in the short term and particularly in the early stages of an economic or market downturn. The Fund has a management fee that is comprised of a base fee of 0.15% which is applied to the Fund's average annual net assets and a performance-based management fee of +/-0.70%. Performance-based management fee adjustments modify the base fee upward or downward depending on the Fund's performance relative to the applicable market index over a rolling five-year performance period, and are calculated based on the Fund's average daily net assets over the most recent five-year period ending on the last day of the quarter. As a result the management fee may change from year to year and may be higher or lower than the fee stated above.

The S&P 500 Index is a broad-based, unmanaged measurement of the stock market, based on the average performance, over any given period, of 500 widely held common stocks. The Russell 2000 Index is an unmanaged, market-value-weighted index that measures the performance of the 2,000 companies that are between the 1,000th and 3,000th largest in the market. Both indexes assume that all dividends are reinvested. It is not possible to invest directly in an index.

Price-to-earnings ratios, price-to-book ratios, and price-to-cash flow ratios all express the value of a stock's most recent closing price as divided by the underlying company's earnings per share, book value per share, or cash flow per share (respectively), all as computed over the previous 12 months. **Price/Cash Flow ratio** is a measure of the market's expectations of a firm's future financial health. Because this measure deals with cash flow, the effects of depreciation and other non-cash factors are removed. Similar to the price/earnings ratio, this measure provides an indication of relative value. **Beta** is a quantitative measure of the volatility of the fund relative to the S&P 500 over the past three years. A beta above one is more volatile than the overall market, while a beta below one is less volatile.*
